# **Overview**

LPL Research has made changes to the asset allocations within the Model Wealth Portfolios (MWP). In the Diversified and Diversified Plus Tactical Mutual Fund models, we increased exposure to emerging market (EM) stocks and modestly increased risk in most investment objectives (IO).

In the Aggressive Growth (AG) IOs, we primarily trimmed domestic large cap value exposure to purchase EM equities. In all other IOs, we primarily targeted a reduction in investment-grade corporate bonds to purchase EM equities. We believe additional EM equity exposure and a small increase in overall equity exposure will modestly increase portfolio risk levels relative to IO benchmarks.

We believe investors' reactions to trade risks have provided an opportunity to add exposure to EM equities at attractive valuations. While we recognize that trade disputes have the potential to dampen prospects for economic growth and earnings growth in EM economies, we believe current valuations for EM stocks reflect an overly pessimistic view on tariff outcomes.
